



Zoo Day Camp Information and Guidelines

Jr. Zoo Keeper (JZK) – Day Camp is for youth between the ages of 9 and 12 and Zookeeper Apprentice Day camp (ZKA) is for youth between the ages of 13 and 15. Participants must be at least 9 years old by date of camp. They must be mature, responsible, able to follow rules, and work under minimal supervision. Participants will be outside and active for most of the day. JZK's and ZKA's will be expected to arrive in comfortable tennis shoes or work boots, comfortable pants that are not torn or shorts that come to just above the knee. A light, hooded jacket is recommended but not required – please label your jacket if one is brought. Proper attire is required. Participants that arrive unprepared will not be able to participate. All JZK and ZKA Campers will receive a t-shirt and ID badge at sign-in. Please include your child's t-shirt size on the registration form.

If your child has allergies or asthma and has an epi-pen or inhaler, please note this on the registration form. Zoo employees are trained in first-aid but will not administer medication except in emergency situations. If your child requires sun block, please send it with them. They will have opportunities to put on sunscreen during bathroom breaks. If these items are required for your child, please have them carry them in a fanny pack style pouch, no large packs or bags. Please label all items.

Snacks and lunch will be provided. If your child has a food allergy, please note it on the Parental Consent Form. If the Zoo is unable to accommodate the allergy, you may be required to provide your child's lunch and two snacks.

Activities may include:

- Building fun enrichment items for the animals
- Watch and learn as the keepers train the cats!
- Feeding different animals
- Touring the zoo and behind the scenes!
- And helping the keepers with daily tasks such as preparing animal diets.

Also included:

- Zoo Day Camp T-shirt
- Lunch at the Cougar Café
- Water bottle
- Zoo Day Camp photo and certificate
